A compliance report of officers relieved should reach the Deputy Commissioner of Customs, ASO by the concerned Deputy/Assistant Commissioner in charge of the section. Non-compliance of the above would be viewed seriously.

4. It shall be ensured by officers being relieved that “a proper handing over note” is prepared enumerating pendency and important items of pending work and handover the same to “relieving officer” on the date of relieving.

5. All the representation/requests received so far from the Appraiser of Customs regarding transfers/postings matters hereby stand disposed off.
