Kind attention is invited to Order No. 40-3/2020-DM-I(A) dated 29.04.2021 issued by the Ministry of Home Affairs, Order No. DMU/2020/CR.92/DisM-1 dated 13.04.2021, Order No. DMU/2020/CR.92/DisM-1 dated 21.04.2021, Order No. DMU/2020/CR.92/DisM-1 dated 29.04.2021, Order No. DMU/2020/CR.92/DisM-1 dated 12.05.2021, Order No. DMU/2020/CR.92/DisM-1 dated 30.05.2021 and Order No. DMU/2020/CR.92/DisM-1 dated 04.06.2021 issued by the Govt. of Maharashtra, DoPT OM F.No.11013/9/2014-Estt.A.III dated 19.04.2021, OM F.No.11013/9/2014-Estt.A.III dated 28.05.2021 and OM F.No.11013/9/2014-Estt.A-III dated 14.06.2021 vide which instructions and guidelines have been issued, to contain the spread of Covid-19, for strict compliance by all Ministries/Departments/Offices of the Central Government.

2. In view of the above mentioned Orders and O.M.s and keeping in view that this office is engaged in essential services, it has been decided that the officers and staff of Mumbai Customs Zone-II as per the enclosed Annexures A, B, C, D, E and F, shall attend the office to render the essential services of Mumbai Customs Zone-II during the period 16.06.2021 to 30.06.2021. However, this does not apply to personnel already working in Sections under respective shifts, roster system or to personnel in Sections not specifically mentioned by name in these Annexures herein, who shall for maintenance and delivery of essential services continue to follow their respective shifts, rosters or shall work at full capacity as directed by the controlling Pr. Commissioner/Commissioner, as the case may be.

3. The officers working from home from 16.06.2021 to 30.06.2021, as per this order, shall make suitable arrangements for disposal of work from home; stay at home; stay in constant touch with their controlling officers, be available on telephone and by other electronic means of communications at all times and would attend office if called for, due to any exigency of work.


4. The Additional/Joint Commissioners of their sections will closely monitor the working of the sections and of the officers' working from home, to ensure that no aspect of work is adversely affected and to ensure that the particular staff is recalled no sooner the need is anticipated.
