

2. The Dy./Asstt. Commissioner in charge of Group/Section Unit shall entrust the additional charge and transfer the relevant Bills of entry/files to any other A.O/Supdt under his charge, if any of the A.O/Supdt, under his charge does not report to duty for any reason by 11:00 A. M. to ensure that the work is not held up.

3. The officer proceeding on leave/training shall also inform his link officer regarding his absence and ensure smooth functioning.

4. The office order supersedes earlier orders issued in this regard.
