In terms of section 4 of the Sexual Harassment of Women at workplace (Prevention, Prohibition and Redressal) Act 2013, Internal Complaint Committee (ICC) for NS-1, Zone-II as under is constituted to deal with the complaints relating to Sexual Harassment at workplace.

- 2. The ICC shall meet at regular intervals (once in a quarter) to discuss varied issues concerning women and steps required to be taken for redressal of grievances, if any. Any aggrieved women employee of this Commissionerate can file a complaint before the 'Internal Complaints Committee'. The ICC will look into such complaints and grievances by conducting enquiries and act upon them in such a manner as laid down vide Sexual Harassment of Women at workplace (Prevention, Prohibition and Redressal Act, 2013 and in accordance with Sexual Harassment of Women (Prevention, Prohibition and Redressal) Rules framed under this Act.
- 3. The ICC shall prepare an Annual Report giving full account of the activities carried out by it during the year and forward copy of the same to the Pr. Chief Commissioner of Customs, Mumbai Zone- Il for information and necessary action, if any.

4. In the event of transfer of any member out of this Commissionerate, the Member should give prior intimation to enable the nomination of another Member at his/her place.
