4 . BCBA के द्वारा उठाया गया कार्यबिन्दु संख्या/ AGENDA POINT RAISED BY BCBA:

कार्यबिन्द् संख्या/POINT NO. 1: Process for regeneration of digital S/bill Print

We wish to bring to your kind attention an issue being faced by members of the trade regarding the non-generation of the final print of Shipping Bills. It has been reported that in several cases, the final processed Shipping Bills are not being received via email, nor are they available for download on the ICEGATE portal. In some instances, even after the Let Export Order (LEO) has been granted for more than 48 hours, the documents remain inaccessible, and the download link on ICEGATE appears greyed out.

This situation is causing operational difficulties for Custom Brokers and Exporters.

Suggestion: It is requested that a defined process or a system provision be established for the regeneration of such Shipping Bill prints to facilitate smooth operations for the trade. In cases where the Digital Print is not available, we seek assistance for print from the EDI System and its acceptance by all stakeholders.

प्रतिक्रिया/Response: The Additional Commissioner of Customs, NS-II informed that the issue concerning the non-receipt of copy of finally processed shipping bills after grant of LEO to the registered email of Customs Brokers/ Exporters and the unavailability of copy of the same on the ICEGATE portal was already flagged to ICEGATE for resolution via email dated 14.10.2025 by EDI. Further, the Chair requested the trade to give a detailed representation along with screenshots of technical difficulties being faced by for taking up the issue with DG Systems.

<u>कार्यबिन्दु संख्या/POINT NO. 2:</u> RODTEP Amount Displayed as Zero for LEOs Dated 30.09.2025

We are writing to report an urgent and critical issue concerning Shipping Bills for which LEO was processed on September 30, 2025, specifically related to the RODTEP benefit. Based on feedback received from trade, we understand

that Shipping Bills (for with LEO granted on 30/09/2025) are reflecting RODTEP amount as zero in the final LEO copy. However, the applicable RODTEP amount, as per the laid down guidelines, was visible in the First Assessed Copy of the Shipping Bill. This discrepancy is causing significant concern regarding the correct processing and disbursement of RODTEP benefits to exporters along with the need for an immediate resolution mechanism for the same.

Additionally, it has been brought to the notice of the Association that fees of Rs. 1,000/- per Shipping Bill are being levied towards LEO cancellation on account of RoDTEP/system-related issues.

Request: We seek a clarification on the matter and necessary corrective action to resolve the issue and prevent such occurrences in the future.

प्रतिक्रिया/Response:

The Chair informed that the issue of non-reflection of RODTEP amount in the finally processed shipping bills was already flagged to DG Systems by the EDI and the issue has been resolved. Accordingly, LEOs of all such Shipping Bills wherein RODTEP was shown as zero even though it was claimed while filing Shipping Bills were cancelled and fresh LEOs were given without carrying out any amendment in the Shipping Bill Further, it was informed by the Chair that since this was a system-related error, no penalty was imposed in such cases thereafter.

<u>कार्यबिन्दु संख्या/POINT NO. 3:</u> Request to Allow LEO for Export Pharma Shipments in Absence of Valid GMP Certificate

We wish to bring to your kind attention that during the export of pharmaceutical consignments, queries are being raised at the docks in cases where a valid GMP certificate is not available at the time of export, even though:

- a) The GMP certificate was valid on the date of manufacturing; or
- b) The shipper has submitted documentary proof of having applied for GMP renewal.

In such instances, ADC NOC is duly available. However, it is observed that Customs officers are re-forwarding the documents to the ADC office for further clarification, which results in increased dwell time and delay in export clearance.

We therefore request that Customs may kindly allow issuance of Let Export Order (LEO) based on the ADC NOC already obtained in the above cases.

प्रतिक्रिया/Response: The issue was explained in detail by the representative from BCBA. Thereafter, the Additional Commissioner, NS-II informed that this issue along with other issues raised by pharma exporter received from Pharmexcil, have been forwarded to Assistant Drugs Controller, CDSCO for comments/inputs/feedbacks so that a holistic approach is adopted and an institutional mechanism is framed to deal with these issues. Based on the reply from ADC/CDSCO, this office will suitably examine the request by the trade.

Further, the Chair instructed the trade to ensure and disseminate timely renewal of GMP and other mandatory compliance certificate requirement among member exporters, so that it is available at the time of export.

- 5. The members of the meeting were informed that the date of next PTFC meeting(Export & General) shall be informed in due course. Association members were requested to forward their agenda points, if any, at least 07 working days in advance by e-mail to Appraising Main (Export) on apmainexp@jawaharcustoms.gov.in.
- 6. The meeting ended with a vote of thanks to the Chair.
