# <u>Point No. 1: Guidelines required for final assessment of SB pertaining to Pharmaceutical products:</u>

The BCBA mentioned that exporters are enquiring regarding the finalisation of the shipping bills assessed provisionally prior to the issue of DGFT PN No. 05/2018 and JNCH PN NO. 77/2018.

**Discussion**: The Comissioner of Customs, NS-II informed that there is no need to upload the data on Dava.com for the consignments manufactured on or before 15.11.2018 as per DGFT PN No. 05/2018 and JNCH PN NO. 77/2018. All DC/Docks should finalize all such provisional shipping bills based on said PN issued by JNCH.

### Point No.2: Pending IGST Refunds and Drawback :-

The BCBA have pointed out that exporters and members of trade have enquired regarding pending IGST refund claims and drawback claims.

**Discussion :** The Commissioner of Customs, NS-II informed that a dedicated IGST refund cell has been formed for faster clearance of IGST refund and also a special drive for sanction of pending IGST refund claims is being conducted from 31<sup>st</sup> May, 2018 to 14<sup>th</sup> June, 2018 (Public Notice 90/2018 dated 30.05.2018).

#### Point No 3: Centralised Parking Plaza:-

BCBA has requested for proper information regarding infrastructure user facilities, working space for Customs brokers and provisions for export examination.
