Pursuant to Cadre restructuring and re-organisation of field formations under CBIC and

Public Notice No. 91/2018 dated 30.05.2018 regarding Jurisdiction of Commissionerates (Nhava

Sheva-1, II, III, IV, V, General) under Mumbai Customs Zone-II and other Public Notices/Standing

Orders issued from time to time, it has been decided to fix Sanctioned strength and allocate

working strength among various sections of JNCH. This would reduce adhocism in allocation of

manpower to different sections and would also result in optimum utilization of working

strength of officers posted in Mumbai Customs Zone-II.

2. The Sanctioned Strength and allocated working Strength in each of the

iv.) The work related to RTI (General and Service/Establishment matters) shall be looked

after by P&E Section.

v.) The work handled by Reception PRO shall be looked after by the Control Room.

vi.) The work handled by Sevottam section shall be looked after by AM(I).
